What are BREEAM Assessments

BREEAM (Building Research Establishment Environmental Assessment Method) assessments score, award and highlight innovative developments that are sustainably designed and constructed in a manner that is above and beyond building regulations requirements. BREEAM Assessments are seen both in the UK and internationally as the foremost indicator for sustainable building design.

Buildings that are BREEAM certified prove that design teams have considered the wide array of environmental and social impacts of the development, and have specified and installed measures to improve these impacts through design, to the construction and future occupancy.

BREEAM is a credit scoring assessment used to generate a specific sustainability performance rating for the building ranging from a "Pass" to an "Outstanding" rating. The areas assessed by the BREEAM Assessments are:
